Whereas the aforesaid notices of attachment nos. **11893 & 11894 of 2024** dated **February 9, 2024**, were issued, attaching the Bank/Locker/Demat accounts and Mutual Fund Folios of the Defaulter, by the Recovery Officer in execution of Certificate No. **RC7519 of 2024** dated **January 17, 2024**, for recovery of funds, of a sum of **Rs. 5,26,000/- (Rupees Five Lakh Twenty-Six Thousand Only)** along with further interest, all costs, charges and expenses etc., against **Metrocity Suppliers Pvt Ltd (PAN: AAHCM2162R)** in the matter of Gokul Solutions Ltd.
2. And whereas the aforesaid notices of attachment nos. **11905 & 11906 of 2024** dated **February 15, 2024**, were issued, attaching the Bank/Locker/Demat accounts and Mutual Fund Folios of the Defaulter, by the Recovery Officer in execution of Certificate No. **RC7530 of 2024** dated **January 19, 2024**, for recovery of funds, of a sum of **Rs. 68,17,416/- (Rupees Sixty-Eight Lakhs Seventeen Thousand Four Hundred and Sixteen Only)** along with further interest, all costs, charges and expenses etc., against **Metrocity Suppliers Pvt Ltd (PAN: AAHCM2162R)** in the matter of Gokul Solutions Ltd.
3. And whereas a Notice of Attachment in the above proceedings dated February 9, 2024 and February 15, 2024 w.r.t Certificate nos. RC7519 of 2024 and RC7530 of 2024 were issued attaching the Bank and Demat accounts of the Defaulters.
4. And whereas, defaulter filed an appeal no. 221 of 2024 before Hon'ble SAT against the Quasi-Judicial Order QJA/GR/IVD/ID16/29180/2023-24 dated September 8, 2023 ["Order"]. The Hon'ble SAT vide its order dated April 16, 2024 has allowed interim relief to the defaulter with direction to deposit a sum of Rs. 2.5 lakhs to SEBI. Further, Hon'ble SAT vide order dated June 12, 2024 clarified that the operation of the impugned Order shall remain stayed.





5. And Whereas, SEBI has recovered such an amount from the defaulter in compliance with the above mentioned directions of SAT against partial settlement of demand raised in the aforesaid recovery certificates.
6. In view of the above, you are hereby directed to release the Bank Accounts/ Lockers, Demat Accounts, Mutual Fund Accounts of the Defaulter, if any, pursuant to the above said notice(s) of attachment.
