It may be recalled that the Recovery Officer vide the subject Attachment Proceedings in **Recovery Certificate No. 7956 of 2024** had directed attachment of Bank Account(s)/ Mutual Fund Folio(s) of **Purvi Shah (PAN: N/A) ["Defaulter"]** with further interest, all costs, charges and expenses, etc.

2. A Notice of Demand dated September 03, 2024 was issued to the defaulter. However, as payments were not made, notices dated November 25, 2024 for Attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) were issued.

3. Whereas the outstanding dues from the defaulter as on date is an amount of Rs. 1,17,000/- (Rupees One Lakh and Seventeen Thousand Only).

Accordingly, you are hereby directed to remit amount to the extent as mentioned in **Para 3** above lying in the account of the defaulter with your Bank/ Mutual Fund, forthwith to SEBI by way of direct credit through EFT/NEFT/RTGS to "**SEBI Recovery Proceeds A/C**" No. **SEBIRRDPEN7956** of **ICICI Bank [IFSC Code- ICIC0000106]** immediately and intimate the remittance details by email to recoveryho@sebi.gov.in/ naveenm@sebi.gov.in in the format as given in table below:

Note: In the absence of confirmation of e-payment as per the above format, the credits made will not be accounted towards the dues.

5. However, if the defaulter is not having any type of account/folios with you, the same need not be informed to SEBI.

This direction is issued in exercise of powers conferred under section 28A of the SEBI Act, 1992 as amended by the Securities Laws (Amendment) Act, 2014 r/w section 220 to 227, 228A, 229, 232, the Second and Third Schedules to the Income-tax Act 1961 (43 of 1961) and the Income-tax (Certificate Proceedings) Rules, 1962 of the Income-tax Rules.
