- Whereas a **Certificate No. RC7267 of 2023 dated October 25, 2023**, has been drawn up by the Recovery Officer against **Sriyans Rocks & Granite Pvt Ltd (PAN: AAACW7644M) ["Defaulter"]** and the sum of **Rs. 5,31,000/- (Rupees Five Lakh Thirty-One Thousand Only)** along with further interest, all costs, charges and expenses was due from them in respect of the said certificate in the above Recovery Proceedings for recovery of the said sum, for non-payment of penalty imposed by the Adjudicating Officer vide Order No. Order/AK/AS/2023-24/26271 dated May 09, 2023 against Sriyans Rocks & Granite Pvt Ltd (PAN: AAACW7644M) in the matter of Illiquid Stock Options.
- And whereas a Notice of Attachment in the above proceedings dated **November 14, 2023** was issued attaching the Bank and Demat accounts of the Defaulter.
- And whereas, SEBI has recovered an amount of **Rs. 5,41,000/- (Rupees Five Lakh Forty-One Thousand Only)** under protest from the Defaulter, which includes interest and costs in the aforesaid recovery certificate.
