 - d) Complete details of all loan/advances accounts along with the details of assets charged for the said loan/advances.
6. If the Defaulter is not having any type of account/s with your bank, then the same need not be informed to SEBI
7. You are also directed to immediately attach any new account/s opened by the defaulter with your Bank post issuance of this notice of attachment and intimate the same on the **email: ravindrap@sebi.gov.in / pankajs@sebi.gov.in** along with the details of the new account/s.
