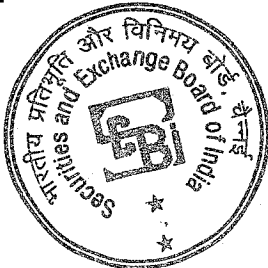
Whereas the Recovery Certificate No. 4942 of 2022 dated June 17, 2022 was drawn against Shri Vinodkumar M Jain (PAN – AADPV2148M) for sum of Rs. 5,56,000/- (Rupees Five Lakh Fifty-Six Thousand only) along with further interest, all costs, charges and expenses incurred for non-payment of penalty imposed by the Adjudicating Officer vide Order No. Order/VV/NK/2021-22/13274 dated August 31, 2021 in the matter of Dealings in Illiquid Stock Options at BSE.

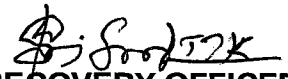
