1. It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 3277 of 2021 dated February 15, 2021** had directed attachment of bank / demat accounts and mutual fund folios of **Capital Mirror and its Proprietor Mr. Saurabh Samir (PAN: GAUPS3690J) ["Defaulter"]** as given below in the matter of Way2Gains, Capital Mirror and Astro Capital Solutions. against the total dues of **Rs. 4,32,30,013/- (Rupees Four Crore Thirty-Two Lakh Thirty Thousand and Thirteen only)** along with further interest, all costs, charges and expenses etc.

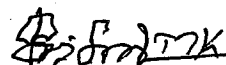
