It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 8235 of 2024 dated October 24, 2024** had directed attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) of **Rocket Tips -Prop Mehul Pravinbhai Jiyani (PAN: AGPPJ1611H) ["Defaulter"]** against the total due of Rs. 3,06,34,630/- (Rupees Three Crore Six Lakh Thirty Four Thousands Six Hundred Thirty Only) with further interest, all costs, charges and expenses, etc.
