**Release of attachment on immovable property attached vide Prohibitory Order

1. Whereas a Recovery Certificate No. 832 of 2015 dated December 11, 2015 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs.25,93,76,885/- (Rupees Twenty-Five Crore Ninety-Three Lakhs Seventy-Six Thousand Eight hundred and Eighty-Five Only) along with further interest, all costs, charges and expenses etc. against Himlaksh Tradelinks Pvt. Ltd. (PAN: AABCH4118E) and its directors/promoters namely Mr. Karan Singh Shekhawat (PAN: ABNPS2860E) and Ms. Meena Shekhawat (PAN: ANPPS5588P) ["Defaulters"].
2. And whereas vide Prohibitory Order No. 335 of 2022 dated November 23, 2022, the Recovery Officer has attached the below mentioned immovable property of the Defaulter prohibiting him from transferring or charging the property in any way and prohibiting all persons from taking any benefit under such transfer or charge.
