1. Whereas a Recovery **Certificate No.463 of 2014** dated 14.11.2014 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs.12,52,178/- (Rupees Twelve Lakh Fifty Two Thousand One Hundred and Seventy Eight Only) along with further interest, all costs, charges and expenses etc. against **Bharat Chandmal Jain ["Defaulter"] PAN: AACPJ0602M** and the same is due from him in respect of the said certificate. A Notice of Demand dated 14.11.2014 has been issued to **Bharat Chandmal Jain**. It may be noted that the amount outstanding as on date is Rs.22,08,503.85/- (Rupees Twenty Two Lakh Eight Thousand Five Hundred and Three and Eighty Five Paise Only).
2. And whereas there is sufficient reason to believe that the Defaulter may dispose off the securities in the Mutual fund folio/s held with you and realization of amount due under the certificate would in consequence be delayed or obstructed.
3. It is, therefore, in exercise of powers conferred on me, I hereby order to attach the following with immediate effect :
 - i) All Mutual fund folio/s by whatever name called of the Defaulter, either singly or jointly with any other person/s, held with you.
4. It is further ordered with immediate effect that **No Debit** shall be made in the said folios until further orders. However, the credits, if any, into the account may be allowed.
5. You are hereby directed to provide the following immediately to the undersigned/our representative on service of this Notice.
 - a) Details of all the Accounts/folios held by the defaulter with you; either singly or jointly with any other person/s,
 - b) Copy of the Account Statement/s; and
 - c) Confirmation of Attachment of the said accounts/folios
6. If the defaulter is not having any type of folios with you/not having any balance in the account/folios of the defaulter, the same shall be also informed on the email: recoveryho1@sebi.gov.in/ vidishab@sebi.gov.in
