Whereas Recovery Certificate No. **RC 4473 of 2022 dated January 24, 2022** has been drawn up by the Recovery Officer against **Mr. Girishkumar Prabhudas Ruparel (PAN: AIPPR8860G) ["Defaulter"]** for recovery of a sum **Rs. 5,57,384/- (Rupees Five Lakh Fifty-Seven Thousands Three Hundred Eighty-four Only)** along with further interest, all costs, charges and expenses etc. for non-payment of penalty imposed by SEBI Adjudication Order Authority vide Order No. PM/NR/2020-21/10422-10428 dated 15/02/2021 in the matter of Atlanta Infrastructure and Finance Limited.

6. **This is without prejudice to any other order of attachment or freeze by the competent authority under any law.**
