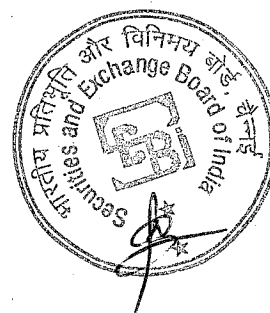

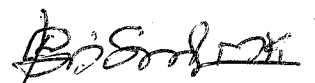
Note: In the absence of confirmation of e-payment as per the above format, the credits made may not be accounted towards the dues.
