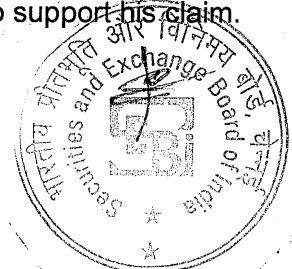
Description of the property

Boundaries

North: 33'-0" Wide Road
South: Private Houses
East: MIG. House No. 181
West MIG House No. 179
and situated within the Sub-Registration District of Nallapadu.

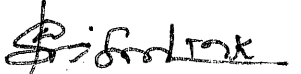
