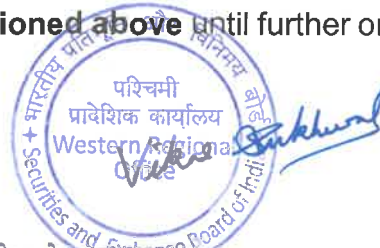

- If the defaulter is not having any type of account with your bank, then the same need not be informed to SEBI.
