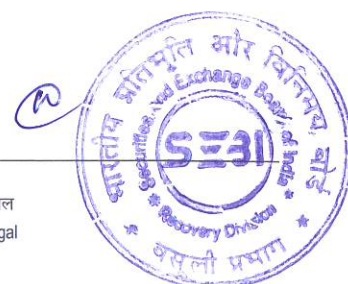

Subject: Remittance of amounts lying in the attached bank accounts/ mutual fund folios of the defaulters vide Attachment Proceedings no. 5258 & 5259 of 2019.

1. It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. RC2566 of 2019 dated October 23, 2019** had directed attachment of Bank accounts/ demat accounts/ mutual fund folios of (1) Amrit Projects Ltd. Accordingly, you are hereby directed to remit amount to the extent as mentioned in Para 3 above lying in the accounts of the Defaulter(s) with your Bank except 50% of the amounts lying in the joint savings account nos. 53003866337, 38460455124, 37810011622, 37810006112, 37913647040, 38026291975, and 38180704258 (first holder of which is Ms Uma De) being maintained with the State Bank of India, forthwith to SEBI by way of EFT/NEFT/RTGS to SEBI Recovery Proceeds Account with Bank of India having Virtual Account No. SEBIRNDPI2566 (IFSC – BKID00VAN04) immediately and intimate the remittance details by email to recoveryero@sebi.gov.in in the format as given in table below:
