**UNDER SECTION 15-I OF SECURITIES AND EXCHANGE BOARD OF INDIA
ACT, 1992, READ WITH RULE 5 OF SEBI (PROCEDURE FOR HOLDING
INQUIRY AND IMPOSING PENALTIES) RULES, 1995**

In the matter of Trading in Illiquid Stock Options at BSE

FACTS OF THE CASE IN BRIEF:

1. Securities and Exchange Board of India (hereinafter referred to as “**SEBI**”) observed large scale reversal of trades in stock options segment of Bombay Stock Exchange (hereinafter referred to as “**BSE**”). SEBI observed that such large scale reversal of trades in stock options lead to creation of artificial volume at BSE. In view of the same, SEBI conducted an investigation into the trading activities of certain entities in illiquid stock options at BSE for the period April 1, 2014 to September 30, 2015 (hereinafter referred to as “**IP**”).

2. Pursuant to investigation, it was observed that total 2,91,744 trades comprising substantial 81.40% of all the trades executed in stock options segment of BSE during the IP were non genuine trades. The aforesaid non-genuine trades resulted into creation of artificial volume in stock options segment of BSE during the IP. It was observed that Suraj Mal Manot [PAN: AEXPM5953K] (hereinafter referred to as the “**Noticee**”) was one of the various entities who indulged in execution of reversal trades in stock options segment of BSE during the IP. Such trades were observed to be non-genuine in nature and created false or misleading appearance of trading in terms of artificial volumes in stock options and therefore were alleged to be manipulative, deceptive in nature. In view of the same, it was alleged that Noticee had violated the provisions of Regulations 3(a), (b), (c), (d), 4(1) and 4(2)(a) of SEBI (Prohibition of Fraudulent and Unfair Trade Practices) Regulations, 2003 (hereinafter referred to as “**PFUTP Regulations, 2003**”). Accordingly, SEBI initiated adjudication proceedings against the Noticee for the aforesaid alleged violation.

APPOINTMENT OF ADJUDICATING OFFICER

3. Vide order dated June 21, 2021, SEBI appointed the undersigned as Adjudicating Officer under Section 15I of the SEBI Act read with Section 19 of the SEBI Act and Rule 3 of the SEBI (Procedure for Holding Inquiry and Imposing Penalties) Rules, 1995 (hereinafter referred to as ‘**Adjudication Rules**’) to inquire into and adjudge under the provisions of 15HA of SEBI Act, the aforesaid alleged violation by Noticee.

SHOW CAUSE NOTICE AND REPLY

4. A Show Cause Notice dated August 10, 2022 (hereinafter referred to as ‘**SCN**’) was issued through Speed Post Acknowledgment Due (hereinafter referred to as ‘**SPAD**’) on August 10, 2022 to the Noticee under Rule 4(1) of the Adjudication

Rules to show-cause as to why an inquiry should not be initiated against him for the alleged violation of Regulations 3(a),(b),(c),(d) and 4(1), 4(2)(a) of PFUTP Regulations, 2003 and why penalty should not be imposed under section 15HA of the SEBI Act, 1992 for the violations alleged to have been committed by Noticee. In the SCN, the Noticee was informed about the SEBI Settlement Scheme, 2022, in terms of regulation 26 of the Securities and Exchange Board of India (Settlement Proceedings) Regulations, 2018 in the matter of Illiquid Stock Options and in case, Noticee do not wish to avail of the facility under the SEBI Settlement Scheme, 2022, Noticee was given 30 days' time from the date of receipt of the SCN to file a reply. The SCN was duly served on the last known address of Noticee on August 16, 2022.

5. With regard to the SCN, vide email dated January 18, 2023, Mr. Kamal Kumar Jain informed about the death of the Noticee and provided a copy of the Death certificate of the Noticee issued by Kolkata Municipal Corporation. Vide aforesaid email, Mr. Kamal Kumar Jain informed that Noticee was his client. However, no authorization letter in this regard was submitted by Mr. Kamal Kumar Jain. Thereafter, vide email dated January 27, 2023, Mr. Kamal Kumar Jain was requested to provide the requisite authorization letter. Vide email dated February 15, 2023, Mr. Kamal Kumar Jain submitted the copy of the authorization letter dated February 13, 2023 issued by Mr. Manish Kumar Manot, legal heir of Noticee, wherein Mr. Kamal Kumar Jain was authorized to represent Noticee. The death certificate has been verified from the official website of website of Kolkata Municipal Corporation and appears to be in order. The death certificate shows that the Noticee passed away on February 11, 2016. In this regard, it would be in the fitness of things to first decide as to whether on the death of the Noticee, the present adjudication proceedings against him would continue or abate.

6. In this context, it is worth mentioning that in *Girijanandini Vs Bijendra Narain* (AIR 1967 SC 2110), the Hon'ble Supreme Court held that in case of personal actions, i.e., the actions where the relief sought is personal to the deceased, the right to sue will not survive to or against the representatives and in such cases the maxim *actio personalis moritur cum persona* (personal action dies with the death of the person) would apply. It is also relevant to refer to the decision of Hon'ble Securities Appellate Tribunal in *Chandravadan J. Dalal vs. SEBI* (Appeal No. 35/2004 decided on June 15, 2005) wherein it was held that: *"The appeal abates since the appellant during the pendency of the appeal died on 29th November 2004. The appeal accordingly abates. The penalty imposed on the original appellant being personal in nature also abates."*
7. In view of the foregoing, I am of the view that the instant adjudication proceedings against the Noticee are liable to be abated without going into the merits of the case. Accordingly, the SCN dated August 10, 2022 issued against Noticee is disposed of and the adjudication proceedings against Noticee stand abated.
8. In terms of the provisions of Rule 6 of the Adjudication Rules, a copy of this order is being sent to SEBI and to the last known address of deceased Noticee and Mr. Manish Kumar Manot, who is stated to be the legal heir of the Noticee. Further, a copy of this order is also being sent to Mr. Kamal Kumar Jain, who is the authorized representative of Noticee and who informed SEBI about the demise of the Noticee.
