Order releasing Pension amount of Ms. Sheila Shekar in the matter of Arvind Remedies Limited.

1. Recovery Certificate No. 7692 of 2024 dated Feb 26, 2024 was drawn up against Ms. Sheila Shekar (defaulter) PAN: BYVPS3398M in the matter of Arvind Remedies Limited for recovery of Rs. 5,96,000/- (Rupees Five Lakh Ninety-Six Thousand) along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum.
2. Whereas notice of attachment under the above proceedings dated Mar 14, 2024 was issued attaching the bank accounts of the defaulter in the said matter.

And whereas, Ms. Sheila Shekar (defaulter), vide representation letter dated 03.04.2024, *inter alia*, submitted that she receives monthly family pension from Southern Railways in the bank account no. **20031316179** maintained by State Bank of India and provided a copy of the Pension Payment Order on 05.04.2024. It is pertinent to mention that the State Bank of India, vide email dated 15.04.2024 have also confirmed that the above mentioned account no. is a pension account and Ms. Sheila Shekar is a family pensioner.

In view of the above submissions made by Ms. Sheila Shekar and the confirmations received from State Bank of India, you are hereby directed to allow Ms. Sheila Shekar to withdraw the amount to the extent of her monthly family pension received from Southern Railways from the aforementioned bank account.





5. Pursuant to the above mentioned notice of attachment, all other credit amounts, other than her family pension amount, that comes into the said bank account shall be informed to Recovery Officer, SEBI, Chennai.
6. Except the said direction, all other bank accounts/lockers/demat accounts/mutual fund folios of Ms. Sheila shekar pursuant to the aforesaid notice of attachment, shall continue to be attached.
