It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 7522 of 2024 dated January 18, 2024** had directed attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) of **Kapil Kumar Wadwan (PAN: AAOPW6145L) ["Defaulter"]** against the total due of Rs. 10,61,000/- (Rupees Ten Lakh Sixty-One Thousand only) with further interest, all costs, charges and expenses, etc.
