Whereas Recovery Certificate No. 4335 of 2021 dated December 07, 2021 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs. 2,21,515/- (Rupees Two Lakh Twenty One Thousand Five Hundred and Fifteen only) along with interest / costs / charges / expenses etc. against **Kishan Balaram Shigvan (PAN: BAWPS1264D) ["Defaulter"]** for failure to pay the penalty imposed by Adjudicating Officer vide Order dated January 29, 2021.
2. And whereas Notices of attachment dated January 27, 2022 in the above proceedings were issued attaching the Bank Accounts / lockers, Demat Accounts & Mutual Fund Folios of the Defaulter;

In view of the above, you are hereby directed to release the attached Bank Accounts/ Lockers, Demat Accounts & Mutual Fund Folios of the Defaulter with respect to said Attachment Proceeding Nos. 7956 & 7957 of 2022 only. However, the Attachment Proceeding Nos. 9570 and 9571 of 2023 under Recovery Certificate No. 4530 of 2022 shall continue to remain in force till further instructions/directions from SEBI.
