It may be recalled that the Recovery Officer vide the subject attachment proceedings in recovery certificate No. 7635 of 2024 dated February 12, 2024 had directed attachment of Bank accounts **Dinesh Natha Pagi (PAN: ATFP4244B)** ["Defaulter"] against the total dues of Rs. 2,43,000 (Rupees Two Lakh Forty Three Thousand Only) with further interest, all costs, charges and expenses, etc.
