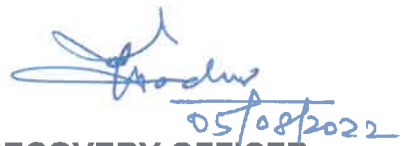
**Attachment Proceeding No. 7993 & 7994 of 2021- Release of attachment on Bank

Whereas Recovery Certificate No. 3320 of 2021 dated March 03, 2021 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs. 1,10,13,603/- (Rupees One Crore Ten Lakh Thirteen Thousand Six Hundred and Three Only) along with interest / costs / charges / expenses etc. against **Terrascope Ventures Limited (formerly known as Moryo Industries Limited) (PAN: AACCM5166G) [(Defaulter)]**.
