Order under Rule 16 and 48 of the Second Schedule to the Income Tax Act, 1961 read with Section 28A of the SEBI Act, 1992

1. Recovery proceedings have been initiated against **Harishankar Paper Products (P) Limited** [PAN- AAACH4932K], in the matter of Cosboard Industries Limited for failure to pay a sum of Rs. 2,16,189 /-, respectively along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of said sum payable in respect of Certificate No. 3963 of 2021 drawn up by the Recovery Officer, Southern Regional Office.
2. A Notice of Demand dated July 12, 2021 was issued by the Recovery Officer to Harishankar Paper Products (P) Limited demanding payment of the said sum along with interest, costs and expenses, within 15 days from the date of receipt of the said notice. The Recovery Officer has attached various bank accounts of the defaulters in execution of the said notice and sent copies of the attachment notice to the defaulters. The defaulter (s) have failed to pay the said dues. The funds available in the bank accounts of the defaulters are not sufficient for recovery of the dues.
3. The Outstanding dues as on date along with further interest, all costs, charges and expenses incurred is **Rs 2,33,732/-**
4. It is learnt that the defaulters are in the possession of the below mentioned property and it is also felt that attaching the said assets would expedite the recovery proceedings.
5. In view of the above, and in exercise of the powers conferred under Rule 16 and 48 of the Second Schedule to the Income Tax Act, 1961 read with Section 28A of the SEBI Act, 1992, the defaulters are hereby prohibited from disposing, transferring, alienating or charging in respect of the following property attached.



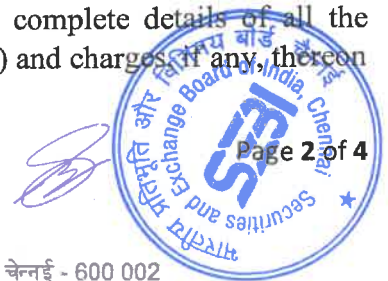

in the format prescribed at **Annexure-A**, along with original title deeds pertaining to the aforementioned properties, within two weeks from date of this order at SEBI, Southern Regional Office, Chennai.

8. This order shall be served on the defaulters and

- i. The Inspector General of Registration of Telangana,
- ii. The concerned Tehsildar, District Registrar and Sub-Registrar of the respective areas where the above mentioned property is located.

with a direction not to act upon any documents purporting to be dealing with transfer, mortgage, charge, lease or creation or alteration of any interest in any of the properties owned / held by the defaulters, including the said property, if presented for registration.
