Cancellation of Recovery Certificate No. 6311 of 2023 issued against Shri Murugan Karthik Meiyappan (PAN – AACPM8115E) in the matter of Dealing in Illiquid Stock Options at the BSE

Whereas the Recovery Certificate No. 6311 of 2023 dated March 13, 2023 was drawn against **Shri Murugan Karthik Meiyappan (PAN – AACPM8115E)** for sum of Rs. 6,91,000/- (Rupees Six Lakh Ninety-One Thousand only) along with further interest, all costs, charges and expenses incurred for non-payment of penalty imposed by the Adjudicating Officer vide Order No. Order/PM/AB/2019-20/6692 dated January 31, 2020 in the matter of Dealing in Illiquid Stock Options at BSE.

Whereas upon receipt of Notice of Demand, Shri Murugan Karthik Meiyappan vide email dated March 14, 2023 informed that he had already paid the penalty of Rupees Five Lakh imposed vide the Adjudication Order dated January 31, 2020.

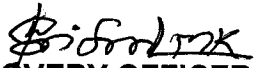
And whereas after enquiry w.r.t. the aforesaid payment, it is observed that the payment of Rs. 5,00,000 (Rupees Five Lakh Only) has already been made by Shri Murugan Karthik Meiyappan in compliance with the said Adjudication Order dated January 31, 2020.

In view of the above and in exercise of powers under sub-section (1) of Section 28A of the Securities and Exchange Board of India Act, 1992 read with Section 224 of the Income-Tax Act, 1961 and Rule 12 of the Second Schedule framed therein, the Recovery Certificate No. 6311 of 2023 dated March 13, 2023 drawn against Shri Murugan Karthik Meiyappan (PAN – AACPM8115E) hereby stands cancelled.
