Cancellation of Recovery Certificate No. 6406 of 2023 dated 12.04.2023 issued against Jayneel Securities Pvt. Ltd. (PAN: AACCJ3163C), Anil Finature Pvt. Ltd. (PAN: AACCA5377K), Jashmin Ramesh Bhyani (PAN: AIXPB6480G), Deepak Khimji Darad (PAN: ADOPD3959J) and Nilesh N. Seth (PAN: AGYPS1051P) in the matter of Omnitech Infosolutions Ltd.

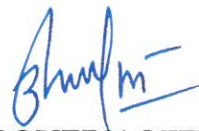
Whereas the Recovery Certificate No. 6406 of 2023 dated 12.04.2023 was drawn against Jayneel Securities Pvt. Ltd. (PAN: AACCJ3163C), Anil Finature Pvt. Ltd. (PAN: AACCA5377K), Jashmin Ramesh Bhyani (PAN: AIXPB6480G), Deepak Khimji Darad (PAN: ADOPD3959J) and Nilesh N. Seth (PAN: AGYPS1051P) (hereafter referred to as 'Defaulters' collectively) for sum of Rs. 26,76,000/- (Rupees Twenty Six Lakh and Seventy Six Thousand only) along with further interest, all costs, charges and expenses incurred for non-payment of penalty imposed by adjudicating officer vide Order/SM/S./2022-23/20852-20856 dated 28.10.2022 in the matter of Omnitech Infosolutions Ltd.

The aforesaid adjudication order dated 28.10.2022 was challenged before the Hon'ble Securities Appellate Tribunal (SAT) in Appeal Nos. 104-106 of 2023 by the Defaulters. The Hon'ble SAT vide order dated 08.11.2023 has quashed the said adjudication order in so far as appellants are concerned.

In view of said Hon'ble SAT order and in exercise of powers under sub-section (1) of section 28A of the Securities and Exchange Board of India Act, 1992; read with section 224 of the Income-tax Act, 1961, the Recovery Certificate No. 6406 of 2023 dated 12.04.2023 drawn against Jayneel Securities Pvt. Ltd. (PAN: AACCJ3163C), Anil Finature Pvt. Ltd. (PAN: AACCA5377K), Jashmin Ramesh Bhyani (PAN: AIXPB6480G), Deepak Khimji Darad (PAN: ADOPD3959J) and Nilesh N. Seth (PAN: AGYPS1051P) hereby stands cancelled.
