Whereas **Recovery Certificate No. 3820 of 2021 dated June 16, 2021** has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of **Rs.19,48,945/- (Rupees Nineteen Lakh Forty Eight Thousand Nine Hundred Forty Five Only)** along with further interest, all costs, charges and expenses etc. against **Anurag Agarwal (PAN: ACDPA4964G)**. The said Recovery Certificate was drawn upon failure to pay the penalty imposed vide Adjudicating Officer's order dated October 09, 2020
2. And whereas Notices of Attachment in the above proceedings dated August 31, 2021 were issued attaching the bank and demat accounts of the defaulter.
3. The aforesaid order of Adjudicating Officer dated October 09, 2020 was challenged before the Hon'ble Securities Appellate Tribunal ("SAT") in Appeal No. 549/2020 and 550/2020. The Hon'ble SAT vide its order dated March 02, 2022 quashed the impugned order and remitted the matter to Adjudicating officer to decide the matter afresh.
4. In compliance of the aforesaid order of Hon'ble SAT, you are hereby directed to release the bank accounts/ lockers/ demat accounts/ mutual fund folios of the defaulters attached, if any, pursuant to the above said notice/s of attachment.
