Notice of Attachment of Bank Account

- Whereas a Recovery Certificate No. 7861 of 2024 dated June 27, 2024 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum Rs. 12,61,000/- (Rupees Twelve Lakhs Sixty One Thousand Only) along with interest/costs/charges/expenses etc. against S Madhavan (PAN: AAPPM2859L) and the same is due from Defaulter in respect of the said certificate. A Notice of Demand dated June 27, 2024 has been issued to S Madhavan [Name of the Defaulter]
- The Outstanding dues as on date is Rs 12,81,000/- (Twelve Lakhs Eighty One Thousand Only) in respect of the said certificate are detailed below.

- It is therefore in exercise of powers conferred on me, I hereby order to attach the following with immediate effect:

- i) All account/s by whatever name called including lockers of the Defaulter, either singly or jointly with any other person/s, held with your Bank; and
 - ii) All other amount/ proceeds due or may become due to the Defaulter or any money held or may subsequently be held for or on account of the Defaulter.
5. It is further ordered with immediate effect that **No Debit** shall be made in the said account/s to the extent of the total dues mentioned above until further orders from the Recovery Officer of SEBI. However, the credits, if any, into the account may be allowed.
6. You are hereby directed to provide the following within 15 days to the undersigned/ our representative on service of this Notice:
- a) Details of all the Accounts including Lockers held by the defaulter with your Bank;
 - b) Copy of the Account Statement(s) for the latest one year in respect of all the Accounts;
 - c) Confirmation of Attachment of the said account(s) and lockers; and
 - d) Complete details of all loan/advances accounts along with the details of assets charged for the said loan/advances.
- If no response is received within 15 days from the date of receipt of this order, it will be presumed that the defaulter is having no bank account/balance with your bank.
7. If the defaulter is not having any type of account with your bank, then the same need not be informed to SEBI.
8. You are also directed to immediately attach any new account/s opened by the defaulter with your Bank post issuance of this notice of attachment and intimate the same to the undersigned along with the details of the new account/s.



9. This Notice of attachment is issued in exercise of powers conferred under section 28A (1), 11(2) (ia) of SEBI Act, 1992 read with section 226 and the Second Schedule to the Income-tax Act, 1961.
