 - b) Confirmation of Attachment of the said account(s) and lockers; and
 - c) Complete details of all loan/advances accounts along with the details of assets charged for the said loan/advances.

If no response is received within 15 days from the date of receipt of this order, it will be presumed that the defaulter is having no bank account/balance with your bank.

5. If the defaulter is not having any type of account with your bank, then the same need not be informed to SEBI.

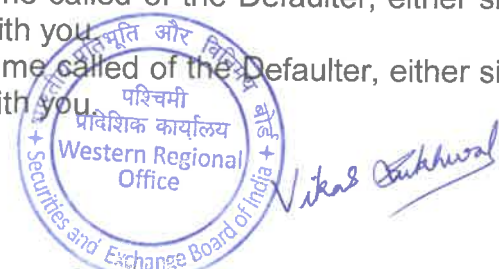
