It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 4470 of 2022 dated January 24, 2022** had directed attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) of **Vasant C Shah (PAN: AESPS2135J) ["Defaulter"]** against the total due of Rs. 23,64,726/- (Rupees Twenty-Three Lakh Sixty-Four Thousand Seven Hundred Twenty-Six only) with further interest, all costs, charges and expenses, etc.
2. Whereas Notice of Demand dated January 24, 2022 has been sent to Defaulter and Notices of Attachment of Bank Account(s) dated November 16, 2023 has been issued to you.
