Whereas Recovery Certificate No. **7574 of 2024** dated **February 02, 2024** was drawn against **IFL Promoters Limited [Defaulter] PAN: AAACI5322C** in the matter of trading in Illiquid Stock Options on BSE and a sum **Rs. 15,91,000/- (Rupees Fifteen Lakh Ninety-One Thousand Only)** was due under the said certificate along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum.
2. And whereas Notices of Attachment dated March 01, 2024 under the above proceedings were issued attaching bank/post office accounts/lockers, demat accounts and mutual fund folios of the Defaulter;
3. And whereas SEBI has recovered the amount of **Rs. 16,21,000/- (Rupees Sixteen Lakh & Twenty-One Thousand Only)** which includes interest and costs towards full and final settlement of demand raised in the aforesaid recovery certificate.
4. In view of the above, you are hereby directed to release bank accounts/lockers, demat accounts and Mutual Fund Folio etc. of **IFL Promoters Limited [Defaulter] PAN: AAACI5322C** attached, if any, pursuant to the above notices of attachment with immediate effect.
5. This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
