It may be recalled that the Recovery Officer vide the subject attachment proceeding in Recovery Certificate No. 7628 of 2024 dated February 12, 2024 directed attachment of Bank Accounts and Mutual Fund Folios of **Victory Sales Pvt Ltd (PAN: AAACV7299K) ["Defaulter"]** against the total due of **Rs. 7,13,000.00 (Rupees Seven Lakh and Thirteen Thousand Only)** with further interest, all costs, charges and expenses etc.
