Release of attachment on immovable property attached vide Prohibitory Order
No. RD/HO/941/2024 dated 15.05.2024

1. Whereas a Recovery Certificate No. 7012 of 2023 dated July 07, 2023 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs. 3,79,000/- (Rupees Three Lakh Seventy-Nine Thousand only) along with further interest, all costs, charges and expenses etc. against Linkhouse Industries Limited (PAN: AAACL6072E) ('Defaulter').

2. And whereas vide Prohibitory Order No. RD/HO/941/2024 dated May 15, 2024 the Recovery Officer has attached the below mentioned immovable properties of the Defaulter prohibiting him from transferring or charging the properties in any way and prohibiting all persons from taking any benefit under such transfer or charge:

- (a) Land bearing survey no. 16/Ka/1 admeasuring about 1.14.28 hectare and
- (b) Land bearing survey no. 86 admeasuring about 1.11.544 hectare situated at Mauza: Dahegaon, P.H. No. 26, Tehsil: Kalmeshwar, District: Nagpur

3. And whereas SEBI has recovered an amount of Rs. 4,39,000/- (Rupees Four Lakh Thirty-Nine Thousand Only), which includes the amount due, with costs and all charges and expenses towards full and final settlement of demand raised in the aforesaid recovery certificate in exercise of powers under sub-section (1) of section 28A of the Securities and Exchange Board of India Act, 1992.

4. In view of the completion of recovery of dues, the Prohibitory Order No. RD/HO/941/2024 dated May 15, 2024 stands rescinded and the properties mentioned at para 2 above are released from attachment in the instant recovery proceedings.

5. This direction is issued in exercise of powers conferred under section 28A of the SEBI Act, 1992 r/w Rule 12 of Second Schedule to the Income-tax Act 1961.
