Whereas Certificate No. **6234 of 2023** dated **February 03, 2023** was drawn against **Channel Nine Entertainment Limited (PAN: AABCC8801H)** and **Gaj Raj Singh (PAN: BEKPS1235N)**, [Defaulters], **Jointly and Severally**, in the matter of **Channel Nine Entertainment Limited** and a sum **Rs. 1,91,00,000/- (Rupees One Crore Ninety One Lakh)** was due under the said certificate.
2. And whereas a Notices of Attachment dated **February 20, 2023** under the above proceedings were issued attaching bank, demat accounts/lockers and mutual fund folios of the entity.
3. And whereas the Hon'ble SAT vide its order dated **10.08.2023** in Appeal no. **140 of 2022**, has *inter-alia* stated the following:

"10.....Hence, the directions of the WTM directing the appellants to refund the money collected through preferential allotment under Section 67 along with interest cannot be sustained and, to that extent the directions are quashed....."

In view of the above, you are hereby directed to release bank, demat accounts/lockers and Mutual Fund Folio etc. of against **Channel Nine Entertainment Limited (PAN: AABCC8801H)** and **Gaj Raj Singh (PAN: BEKPS1235N)**, [Defaulters], **Jointly and Severally** attached, if any, pursuant to the above notice of attachment with immediate effect.
5. This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
