ORDER RELEASING BANK, DEMAT & MUTUAL FUND ACCOUNTS

1. Whereas a **Recovery Certificate No. RC4169 of 2021** dated **September 24, 2021** was drawn up by the Recovery Officer against **Conquer Barter Private Limited (PAN: AADCC8378F) [Defaulter]** for a sum of **9,14,096/- (Rupees Nine Lakh Fourteen Thousand Ninety-Six Only)** along with further interest, all costs, charges and expenses was due from them in respect of the said certificate in the above Recovery Proceeding.
2. And whereas a Notice of Attachment in the above proceedings dated **November 30, 2022** was issued attaching the Bank and Demat accounts of the Defaulter.
3. And whereas, defaulter filed an appeal no. 359 of 2022 before the Hon'ble Securities Appellate Tribunal ("SAT") against the Adjudication Order Order/MC/VS/2020-21/8302-8309 dated July 21, 2020 ["Order"]. The Hon'ble SAT vide its order dated July 08, 2022 reduced the penalty amount by 50% in respect to Conquer Barter Private Limited (PAN: AADCC8378F) in the matter of PS IT Infrastructure and Services Limited.
4. And whereas SEBI has recovered an amount of **Rs. 8,02,830.74/-** (excess amount of Rs. 3,08,758.47) which includes further interest and cost towards full and final settlement of demand raised in the aforesaid recovery certificate.
5. In view of the above, you are hereby directed to release the Bank Accounts/Lockers, Demat Accounts, Mutual Fund Accounts of the Defaulter attached, if any, pursuant to the above said notice/s of attachment.
