



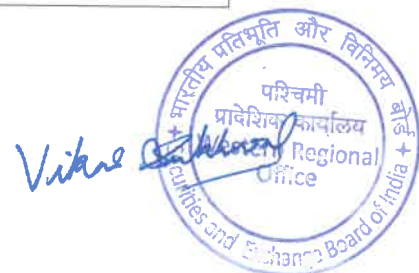

It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 4465 of 2022 dated January 24, 2022** had directed attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) of **Span Dyestuff Industries Limited (CIN: L24231GJ1993PLC020442) ["Defaulter"]** against the total due of Rs. 1,27,137/- (Rupees One Lakh Twenty-Seven Thousand One Hundred Thirty-Seven only) with further interest, all costs, charges and expenses, etc.
