- Whereas **Recovery Certificate No. 2350 of 2019 dated July 03, 2019** has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of **Rs. 8,98,052/- (Rupees Eight Lakh Ninety Eight Thousand Fifty Two Only)** along with further interest, all costs, charges and expenses etc. against **Babubhai Desai (PAN: AKSPD2671E)**. The said Recovery Certificate was drawn upon failure to pay the penalty imposed vide Adjudicating Officer's order dated June 29, 2018.
- And whereas Notices of Attachment in the above proceedings dated September 19, 2019 were issued attaching the bank and demat accounts of the defaulter.
- The aforesaid order of Adjudicating Officer dated June 29, 2018 was challenged before the Hon'ble Securities Appellate Tribunal ("SAT") in Appeal No. 200/2019. The Hon'ble SAT vide its order dated February 19, 2020 set aside the impugned order and remitted the matter to Adjudicating officer to decide the matter afresh.
- In compliance of the aforesaid order of Hon'ble SAT, you are hereby directed to release the bank accounts/ lockers/ demat accounts/ mutual fund folios of the defaulters attached, if any, pursuant to the above said notice/s of attachment.
