Whereas Recovery Certificate No. 301 of 2014 dated July 16, 2014 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs.1,68,595/- (Rupees One Lakh Sixty-eight Thousand Five Hundred Ninety-five only) along with interest / costs / charges / expenses etc. against **Adam Comsof Limited (PAN: AABCA2067R) ['Defaulter']** for failure to pay the penalty imposed by AO order vide Order No. DSR/AO-33/2008 dated November 28, 2008 in the matter of Kolar Biotech Limited.

4. In view of the above, you are hereby directed to release the attached Bank Accounts/ Lockers, Demat Accounts and Mutual Fund Folios of the Defaulter, pursuant to the above said Notice(s) of Attachment, having proceeding Nos. 1092, 1093, 1094 of 2014 & 809 of 2019.
5. If the Defaulters are not having any type of account/folios with you, the same need not be informed to SEBI.
