It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 4415 of 2021 dated December 28, 2021** had directed attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) of **Sanjay Jethalal Soni HUF (PAN: AAWHS0331J) ["Defaulter"]** against the total due of Rs. 48,46,058/- (Rupees Forty-Eight Lakh Forty-Six Thousand Fifty-Eight only) with further interest, all costs, charges and expenses, etc.
2. Whereas Notice of Demand dated December 28, 2021 has been sent to Defaulter and Notices of Attachment of Bank Account(s) dated February 28, 2023 has been issued to you.
