It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 4155 of 2021 dated 21.09.2021** had directed attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) of **Gagabhai Desai Amul (PAN : AHDPD3526G) ["Defaulter"]** against the total due of Rs.45,71,246/- (Rupees Forty Five Lakh Seventy One Thousand Two Hundred and Forty Six only) with further interest, all costs, charges and expenses, etc.

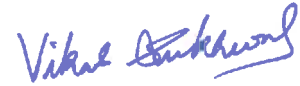
