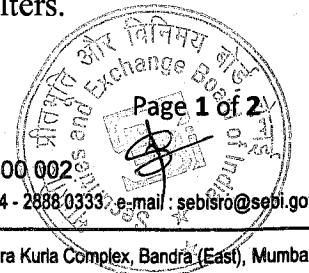

**Order under Rule 16 and 48 of the Second Schedule to the Income Tax Act, 1961
read with Section 28A of the SEBI Act, 1992**

1. Recovery proceedings have been initiated against **BLESSING AGRO FARM INDIA LIMITED [PAN-AADCB6709R]**, **Mr. INNSAIPILLAI LURDPILLAI JOSEPH JEYARAAJ [PAN-ACUPJ0102E]**, **Mrs. PRAKASAM SAGAYA PACKIA SANTHI [PAN-ALKPS4279C]**, **Mr. IRUDAYARAJ MANICKAM PILLAI JEYABALAN [PAN-AJFPJ3454R]** and **Mr. SANTHANAPETER [PAN-BQMPS1649Q] (Defaulters)** for failure to pay a sum of Rs.84,30,01,000/- (Rupees Eighty Four Crores Thirty Lakhs One Thousand Only) along with returns due to investors, along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum payable in respect of Certificate No. 1593 of 2018 dated 11.07.2018 drawn up by the Recovery Officer, Southern Regional Office.
2. Notice of Demand dated 11.07.2018 was issued by the Recovery Officer to the defaulters demanding payment of the said sum along with returns, interest, costs, expenses etc., within 15 days from the date of receipt of the said notice. The defaulters have failed to pay the said dues nor responded to the notices. The Recovery Officer has attached various bank accounts of the defaulters in execution of the said notice and sent copies of the attachment notice to the defaulters. The balances as available in the banks are insufficient to meet the outstanding liability of the defaulters.

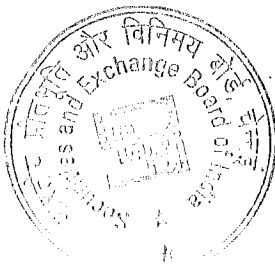

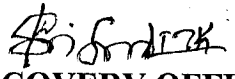
