It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 7413 of 2023 dated November 30, 2023** had directed attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) of **Yadunath Singh Thakur Prop. Of The Apex Global (PAN: ECLPS1036K) ["Defaulter"]** against the total due of Rs. 14,153,772/- (Rupees One Crore Forty One Lakhs Fifty Three Thousands Seven Hundred Seventy Two Only) with further interest, all costs, charges and expenses, etc.
2. Whereas Notice of Demand dated November 30, 2023 has been sent to Defaulter and Notices of Attachment of Bank Account(s) dated August 5, 2024 has been issued to you.
3. Whereas the outstanding dues from the Defaulter as on date is an amount of **Rs. 15,384,448/- (Rupees One Crores Fifty Three Lacs Eighty Four Thousand Four Hundred Forty Eight Only)**.

Accordingly, you are hereby directed to remit the amount to the extent as mentioned in **Para 3** above lying in the account of the Defaulter with your Bank and remit the amount, forthwith to SEBI by way of **EFT/NEFT/RTGS to A/c No. SEBIRNCIS7413 of Bank of India , IFSC Code- BKID00VAN04** immediately and intimate the remittance details by email to recoverywro@sebi.gov.in in the format as given in table below:
