It may be recalled that the Recovery Officer vide the subject attachment proceedings in **Recovery Certificate No. 131 of 2014 dated June 25, 2014** had directed attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) of **Prakash Ceramics Limited (PAN: AABCP8025G) ["Defaulter"]** against the total due of Rs. 4,34,819/- (Rupees Four Lakh Thirty-Four Thousand Eight Hundred Nineteen only) with further interest, all costs, charges and expenses, etc.
