2. The aforesaid order of Adjudicating Officer dated 11.08.2020 was challenged before the Hon'ble Securities Appellate Tribunal ("SAT") in Appeal No. 298 of 2021. Hon'ble SAT vide its order dated 10.06.2022 has allowed the appeal and remitted the matter back to AO.
3. In compliance of the aforesaid order of Hon'ble SAT, you are hereby directed to release the bank accounts/ lockers/ demat accounts/ mutual fund folios of the defaulter attached, if any, pursuant to the above said notice/s of attachment.
