Corrigendum to Order Releasing of Bank Accounts, Demat Accounts and Mutual Fund Folios

1. In view of the above, you are hereby directed to release the bank accounts/ lockers/ demat accounts/ mutual fund folios of **Bhogilal Kubadia (PAN: AHDPK8694A) (Legal Heirs and Husband of Vimlaben Bhogilal Kubadia) (PAN: AGVPK9317R)** attached, if any, pursuant to the above said notices of attachment under intimation to SEBI.
6. If the defaulter is not having any type of account/folios with you, the same need not be informed to SEBI.
7. This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
