Whereas Recovery Certificate No. 3494 of 2021 dated April 15, 2021 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs. 1,08,482/- (Rupees One Lakh Eight Thousand Four Hundred and Eighty Two only) along with further interest, costs, charges and expenses etc. against **Sashi Sureka-HUF (PAN: AACPN9753B) ["Defaulter"]** and the same was due in respect of the said certificate.
2. And whereas Notices of Attachment dated May 24, 2021 in the above proceedings were issued attaching the Bank Accounts/ lockers, Demat Accounts & Mutual Fund Folios of the Defaulter;

And whereas the Hon'ble Securities Appellate Tribunal (Hon'ble SAT) vide its order dated June 09, 2022 under Appeal No. 426 of 2020 has quashed the impugned Adjudication Order No. Order/GR/RK/2020-21/8511-8528 dated July 31, 2020. The present Recovery Certificate No. 3300 of 2021 has been issued pursuant to said Adjudication Order. Since, the said Adjudication Order has been quashed by Hon'ble SAT, hence, the present Recovery Certificate stands cancelled.
4. In view of the above, you are hereby directed to release the Bank Accounts/ lockers, Demat Accounts & Mutual Fund Folios of the Defaulter attached, if any, pursuant to the above said notice of attachment.
