Whereas **Recovery Certificate No. 2353 of 2019 dated July 03, 2019** has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of **Rs. 11,22,315/- (Rupees Eleven Lakh Twenty Two Thousand Three Hundred Fifteen Only)** along with further interest, all costs, charges and expenses etc. against **Shri Sajjankumar Nanwal (PAN: ABJP3315R)**. The said Recovery Certificate was drawn upon failure to pay the penalty imposed vide Adjudicating Officer's order dated June 29, 2018.
2. And whereas Notices of Attachment in the above proceedings dated September 19, 2019 were issued attaching the bank and demat accounts of the defaulter.
3. The aforesaid order of Adjudicating Officer dated June 29, 2018 was challenged before the Hon'ble Securities Appellate Tribunal ("SAT") in Appeal No. 428/2018. The Hon'ble SAT vide its order dated February 19, 2020 set aside the impugned order and remitted the matter to Adjudicating officer to decide the matter afresh.
4. In compliance of the aforesaid order of Hon'ble SAT, you are hereby directed to release the bank accounts/ lockers/ demat accounts/ mutual fund folios of the defaulters attached, if any, pursuant to the above said notice/s of attachment.
