Whereas the aforesaid notices of attachment nos. **11213 & 11214 of 2023 dated September 13, 2023** were issued, attaching the Bank/Locker/Demat accounts and Mutual Fund Folios of the Defaulter, by the Recovery Officer in execution of Certificate No. **RC7099 of 2023 dated August 24, 2023**, for recovery of funds, of a sum of **Rs. 11,31,000/- (Rupees Eleven Lakh Thirty One Thousand Only)** along with further interest, all costs, charges and expenses etc., against **BRH Wealth Kreators Ltd (PAN: AACCB5141L) ["Defaulter"]** along with further interest, all cost, charges and expenses incurred in respect of all the proceedings taken for recovery of the sum;
2. And whereas a Notice of Attachment in the above proceedings dated **September 13, 2023** was issued attaching the Bank and Demat accounts of the Defaulter.
3. And whereas, SEBI has recovered an amount of **Rs. 13,12,549.05/-**, which includes interest and costs from the Defaulter against full and final settlement of demand raised in the aforesaid recovery certificate.
4. In view of the above, you are hereby directed to release the Bank Accounts/Lockers, Demat Accounts, Mutual Fund Accounts of the Defaulter attached, if any, pursuant to the above said notice/s of attachment.
5. If the defaulter is not having any type of account/folios with you, the same need not be informed to SEBI.
6. This is without prejudice to any other order of attachment or freeze by the component authority under any law.
