- Whereas Recovery Certificate Number 2659 of 2019 dated December 06, 2019 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs. 1,31,62,644/- (Rupees One Crore Thirty One Lakh Sixty Two Thousand Six Hundred and Forty Four only) along with interest / costs / charges / expenses etc. against **Hariharan Vaidyalingam (PAN: AABPV4103E) [(Defaulter)]**.
- And Whereas vide Prohibitory Order No. RO/HO1/174 of 2020 dated July 31, 2020, the Recovery Officer had attached the below mentioned two immovable properties of Defaulter prohibiting from disposing, transferring, alienating, or charging in respect such attached properties:

- Accordingly, the SEBI Prohibitory Order No. RO/HO1/174 of 2020 dated July 31, 2020 stands rescinded.
- This order shall be served on the concerned Sub-Registrars of the areas where above mentioned properties are located and Inspector General of Registration & Controller of Stamps of Maharashtra for their information and to cancel SEBI's encumbrances/ lien, if any, so created in respect of such properties in their record. Further, this order shall also be served on Defaulter.
