It may be recalled that the Recovery Officer vide the subject Attachment Proceedings in **Recovery Certificate No. 8415 of 2024** had directed attachment of Bank Account(s)/Mutual Fund Folio(s) of **Subhash Dayama (PAN: ABIPD7932M)** ["Defaulter"] with further interest, all costs, charges and expenses, etc.

2. A Notice of Demand dated December 04, 2024 was issued to the defaulter. However, as payments were not made, notices dated December 26, 2024 for Attachment of Bank/Demat Account(s) and Mutual Fund Folio(s) were issued.

3. Whereas the outstanding dues from the defaulter as on date is an amount of Rs. 21,61,000/- (Rupees Twenty One Lakh and Sixty One Thousand Only).

Note: In the absence of confirmation of e-payment as per the above format, the credits made will not be accounted towards the dues.
