- 1) Whereas Recovery Certificate No. 8884 of 2025 dated September 02, 2025 was drawn against Abhinesh Kumar (PAN: AGWPK6944M) ["Defaulter"] for sum of Rs.5,46,000.0/- (Rupees Five Lakh Forty-Six Thousands Only) along with further interest, all costs, charges and expenses incurred in respect of all the proceedings taken for recovery of the said sum, for non-payment of penalty imposed by Adjudicating Officer vide Order No. Order/AS/VC/2024-25/31171 dated January 31, 2025 in the matter of ISO at BSE-ABHINESH KUMAR

- 4) In view of the above, you are hereby directed to release bank accounts/lockers, demat accounts and Mutual Fund Folio etc. of Abhinesh Kumar (PAN: AGWPK6944M) attached, if any, pursuant to the above notices of attachment with immediate effect.
- 5) This is without prejudice to any other order of attachment or freeze by the competent authority under any law.
