1. Whereas a Recovery **Certificate No.129 of 2014** dated 24.06.2014 has been drawn up by the Recovery Officer in the above proceedings for recovery of a sum of Rs. 9,83,795/- (Rupees Nine Lakhs Eighty Three Thousand Seven Hundred Ninety Five Only) along with further interest, all costs, charges and expenses etc. against **Kishan Agarwal ["Defaulter"] (PAN: Not Available)** and the same is due from him in respect of the said certificate. A Notice of Demand dated 24.06.2014 has been issued to **Kishan Agarwal**. It may be noted that the amount outstanding as on date is Rs. 8,01,000/- (Rupees Eight Lakhs One Thousand Only).
2. And whereas there is sufficient reason to believe that the Defaulter may dispose off the securities in the Mutual fund folio/s held with you and realization of amount due under the certificate would in consequence be delayed or obstructed.
2. It is, therefore, in exercise of powers conferred on me, I hereby order to attach the following with immediate effect :
 - i) All Mutual fund folio/s by whatever name called of the Defaulter, either singly or jointly with any other person/s, held with you.
3. It is further ordered with immediate effect that **No Debit** shall be made in the said folios until further orders. However, the credits, if any, into the account may be allowed.
4. You are hereby directed to provide the following immediately to the undersigned/our representative on service of this Notice.
 - a) Details of all the Accounts/folios held by the defaulter with you; either singly or jointly with any other person/s,
 - b) Copy of the Account Statement/s; and
 - c) Confirmation of Attachment of the said accounts/folios
5. If the defaulter is not having any type of folios with you/not having any balance in the account/folios of the defaulter, the same shall be also informed on the email: recoveryho1@sebi.gov.in/ vidishab@sebi.gov.in
